# RETIREE OPEN ENROLLMENT

The health insurance open enrollment period closes on November 25. Changes are due in the PSRS Office at 4 p.m. on November 25. Retired members enrolled in medical and dental insurance through PSRSSTL should have received an Open Enrollment Packet in the mail in November. Due to the pandemic, there were no in-person open enrollment meetings this year but recorded vendor presentations are available on the PSRS website. All medical enrollee members will receive a new ID card prior to January 1, 2021.

### A Note about 2021 Direct Deposits

The System pays pensions with a payment date on the 1st of each month. In months when the 1st falls on a weekend or holiday weekend, PSRSSTL sends direct deposits by the last business day of the prior month but the funds may not be deposited by the banks until the first business day of the month. In 2021, the 1st will fall on a holiday in January, which means funds may not be available until Jan 4. The 1st will fall on a weekend in May and August but funds should be available the following Monday.
