MINUTES OF THE BOARD OF TRUSTEES REGULAR MEETING

April 19, 2021

I. ROLL CALL AND ANNOUNCEMENT OF A QUORUM

The April meeting of the Board of Trustees of the Public School Retirement System of the City of St. Louis (PSRSSTL) was called to order at around 4:33 p.m. on Monday, April 19, 2021. The meeting was conducted by video conference through Zoom and a Livestream on YouTube. Louis Cross, Chairman of the Board of Trustees, was the presiding officer.

Roll Call was taken, and Angela Banks, Christina Bennett, Louis Cross, Regina Fowler, Sheila Goodwin, Donna Jones, Yvette Levy, Bobbie Richardson, and Albert Sanders were present. The Board of Trustees had a quorum at the meeting. Trustee Justin Stein joined the meeting in progress. Trustee Joseph Clark was absent.

Executive Director, Susan Kane, Attorney Representative, Matt Gierse, Actuary Michael Ribble, and Audit Representatives Jeanne Dee and Brenda Shepherd were also in attendance.

II. APPROVAL OF MINUTES FROM LAST MEETING

Christina Bennett made a motion, seconded by Regina Fowler, to approve the minutes of the Board of Trustees Meetings from February 22, 2021. By voice vote, motion carried.

III. READING OF COMMUNICATIONS TO THE BOARD OF TRUSTEES

Ms. Smith-Costello submitted a letter to the newest Trustee, Ms. Fowler, and newly elected Treasurer, Ms. Goodwin, expressing concern about not receiving her pension benefit in her bank account on the first day of the month when it falls on a weekend. She also expressed concern that her Public School Retirement System pension had never increased since her retirement. In response to the Chairman, the Executive Director explained that a letter had been sent to Ms. Smith-Costello and she had also spoken to her via phone but that the retiree was still concerned about these issues. There was no further discussion on the matter.

Staff will also research any new equipment or materials that may be needed for possible limited office reopening.

VII. REPORT OF THE CHAIRPERSON

The Chairman had no report.

VIII. REPORT OF THE EXECUTIVE DIRECTOR

The Executive Director began by presenting a report regarding Overpayments Made to Deceased Retirees. This chart will be updated and presented at each meeting. Updated information provided on this report indicated that a settlement agreement had been reached with one individual to repay benefits for a deceased retiree that had been sent before the System was aware that the retiree had passed away. The survivor agreed to repay the plan these benefits over several months. So far in 2021, there has only been one overpayment, which has been returned to the System.

The Executive Director then asked the Trustees if they wanted to change the 2021 Board of Trustees Meeting Schedule after reviewing the approved calendar from St. Louis Public Schools. The date for the October Regular Board of Trustees Meeting would conflict with Parent-Teacher Conferences. There was also discussion about changing the Investment Committee date since it would also fall in that same week. However, there was agreement that the Investment Committee date should not be changed since a lower number of Trustees were needed to establish a quorum and this information would be reported back at the Regular Board of Trustees Meeting.

Albert Sanders made a motion to amend the Regular Board of Trustees Meeting Schedule and change the October meeting to October 25. Sheila Goodwin seconded the motion.
