


Annual Report Trivia



The Retirement System's investment portfolio decreased by 4.15% in the Third Quarter 2022 ranking in the 41st percentile of similar public funds. While the returns were negative, the System's overall portfolio experienced less negative returns than peers. Inflation concerns lingered along with fear of a recession. The increasing interest rates, a result of rate hikes pursued by the Federal Reserve, to control inflation also impacted the market. During the one year period ending September 30, 2022, the Retirement System recorded a return on investments of -13.04%. The summaries of the PSRSSTL market value, rankings, investment returns, and asset allocation of funds held in trust on behalf of the membership for the reporting period are listed in the tables below.
